Santa Clara Valley Youth Stewardship Commission

What is the Youth Stewardship Commission?

The Youth Stewardship Commission (YSC) provides a unique opportunity for high school students to explore careers and contemporary water issues from an inside perspective.

What is the YSC's goal?

To inspire, educate, and develop leadership skills that will carry the next generation into a sustainable water future. As the state's water issues become increasingly complex, our need for inspired young leaders grows. Through the YSC, we hope to increase our community's awareness of "one world, one water."

When will the commission meet?

The orientation meeting will take place at 5:30-8:30 p.m. on January 25, 2017 at the following address: 5700 Almaden Expressway, San Jose, 95118 in the Boardroom of the main Headquarters Building. All subsequent meetings will take place on the third Wednesday of every month through June 21, 2017. Refreshments will be provided at each evening.

What activities will commissioners engage in?

Commissioners will:

- Learn about current water issues
- Opportunity to job shadow with professionals at the district
- Tour of state-of-the-art water treatment and reclamation facilities
- Participate in service learning stewardship opportunities



What is the structure of the commission?

Fifteen to twenty (15-20) high school students will be selected to represent Santa Clara County's diverse population. Members will serve a six-month term meeting every month during the academic year. *For the current academic year, the program will run from January through June 2017.

What are the incentives?

- Insight into water career opportunities
- Letters of recommendation for college applications upon successful completion of the program
- Community service hours for graduation requirements
- Networking opportunities with Water District professionals
- Leadership training and development
- Knowledge and awareness of how we manage our County's complex water resources
- Foster meaningful friendships with other empowered young leaders

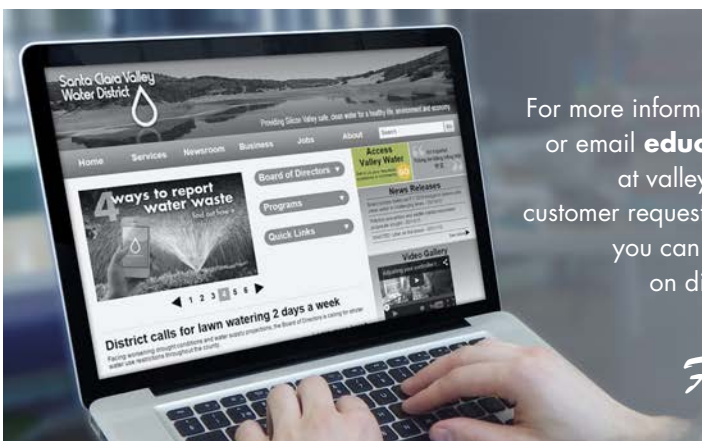
What we do

The Santa Clara Valley Water District manages water resources and provides stewardship for the county's five watersheds, including 10 reservoirs, hundreds of miles of streams and groundwater basins. The water district also provides flood protection throughout Santa Clara County.

What are the criteria for membership on the commission?

Each Youth Commissioner must:

- Be a high school student within Santa Clara County
- Have access to transportation to and from the Water District
- Commit to attending one meeting or activity every month during the academic school year (Jan. - Jun. 2017)
- Participate in 2 additional "electives," including but not limited to: job shadowing a Water District professional; attending National River Clean-up Day on the third Saturday in May; tour of water treatment plant; observing a Board of Directors monthly meeting; and other opportunities
- Have an interest in learning about water conservation, water supply, stream stewardship, flood protection, infrastructure maintenance, water quality and water operations programs
- Complete and submit an application by the deadline and be selected to serve a term. (Note: all selected members will be notified by no later than **Jan. 18, 2017**.)
